University of North Carolina Charlotte Department of Criminal Justice and Criminology Internship Overview

Goals & Objectives

The Masters of Science and Bachelor of Arts in Criminal Justice and Criminology (CJ&C) Internship Program is designed to provide structured and supervised opportunities for practical experience in a criminal justice agency setting that complements students' academic and professional goals.

The objectives are:

- To provide work experience in a discipline of interest.
- To integrate academic knowledge into practice in a professional environment.
- To develop interpersonal skills related to the responsibilities of positions in the field of interest.

Internship Structure

Criteria for Internship Sites

The internship site must be able to:

- provide practical experience in one or more of core disciplines of criminal justice and criminology (law enforcement and private security; social and victim services; courts and legal; sentencing & corrections; juvenile justice & juvenile services; and research), data analytics;
- coordinate entry-level activities that are comparable to graduate and undergraduate students' knowledge and skills;
- offer opportunities for students to interact with staff members and agency clients, if applicable; and
- organize time and space for student education and professional development.

Responsibilities of the Agency Contact/ Advisor

The Agency contact serves as a professional mentor for the student in the internship placement. As such, the Agency contact/ advisor helps students to apply the knowledge and skills they learned in classes to actual work experience in professional practice. The Agency Advisor has the following responsibilities:

- To oversee the student's learning during the internship experience at least 50% of the time;
- To serve as a role model for the student and to advise the student routinely preferably weekly for one hour;
- Provide the intern with adequate information and instruction of safe, effective functioning in the workplace;
- Abide by state and federal laws applicable to employment;

- Make the final selection of internships students in accordance with the Americans with Disabilities Act and Equal Employment Opportunity statutes;
- To consult periodically with the CJ&C Internship Coordinator on the student's progress;
 and
- To complete a student evaluation at the midterm and no later than the last week of the internship experience for fall and spring placements. For summer placements, only 1 evaluation is requested.

Responsibilities of the CJ&C Internship Coordinator

The CJ&C Internship Coordinator serves as the liaison between the student, Agency Advisor, and UNCC CJ&C program, as well as the contact person for all information or questions about CJ&C internships. The coordinator will oversee the relevant internship course, CJ Practicum CJUS 3400/6400.

Responsibilities of the Student

Students are required to:

- Complete all applications and other necessary documentation (e.g., background check, drug screening, etc. as required);
- Complete 120 hours of actual work experience for 3 credit hours (or 240 of actual work experience for 6 credit hours); which equates to approximately 20 hours/week at designated agency (or 40 hours at the agency) that can offer students practical experiences in any of the core disciplines of criminal justice;
- Attend scheduled seminar course, to discuss predetermined topics related to working in criminal justice settings (including *understanding internship experiences, knowing your agency, learning from experience, dealing with diversity in the workplace, developing ethical competences, managing your emotions and dealing with stress, trouble-shooting and making mistakes, and evaluation of your internship experience*) and any issues that arise for students at their internship sites:
- Complete a mid-semester and final evaluation of the internship; and
- Create and analyze agency data to address a concern the agency may have, or the interns identifies.
